Our system automatically includes an attractive cover and a table of contents. Our license allows you to distribute your new custom coursepack through Blackboard.

TIP: You can use the special "compiled by" field on the Build-a-Report screen to put your name and your course information on the cover of your custom courepack.

WRITE A LESSON PLAN

EXAMPLE: You want to create 6 lesson plans for students who are taking a class in retailing. You goal is to make sure your lessons will be challenging and interesting, while covering topics that you feel are vital.

ACTION PLAN: Begin by going to the Professors' Center on Plunkett Research.
